A contentious-administrative appeal may be lodged against this Resolution, which exhausts administrative channels in accordance with the provisions of article 6.4 of Organic Law 6/2001, of 21 December 2001 on Universities, within two months of the day following notification of this resolution, before the Contentious-Administrative Court of the district in which you are domiciled or in Zaragoza, in accordance with the provisions of articles 8.3 and 14.1 of Law 29/1998, of 13 July 1998, Regulating Contentious-Administrative Jurisdiction, of 13 July 1998. You may also lodge an appeal in the Court of Zaragoza, in accordance with the provisions of articles 8.3 and 14.1 of Law 29/1998, of 13 July, Regulating Contentious-Administrative Jurisdiction. Alternatively, an appeal for reconsideration may be lodged against this resolution before this same body, within a period of one month from the month following notification of this resolution, in which case the aforementioned contentious-administrative appeal may not be lodged until an express decision has been handed down or the appeal for reconsideration has been presumptively rejected; in accordance with the provisions of articles 30, 11, 12 and 14 of Law 29/1998, of 13 July 1998, Regulating Contentious-Administrative Jurisdiction.
